Dear Parents,

Registration for our Summer Program will open to currently enrolled families on Monday, April 29, 2024. It will open to the general public on Monday, May13, 2024. Please find attached the Registration Form and information regarding our Summer Program. There is only a registration fee required, \$55 for a single child, \$75 per family, we do not currently charge a deposit for the Summer Program. While we allow parents to choose which weeks they want to register for, in order to hold your registration space for the Fall, there is a minimum requirement of at least **four weeks** throughout the entire summer, with the days per week equaling the number of days you had during the formal school. Please be sure to read the attached Summer Program Policy sheet as it contains important information, particularly regarding the fact that once the program begins on July 8th, you are then financially responsible for whatever weeks you have registered for as we will have then scheduled staff for the program and will need to honor their schedules financially.

The staff and I will be putting together plans for the Summer over the next couple of months, including lots of art activities, cooking/baking projects and science fun! In addition, weather permitting, we will spend lots of time outside engaging in nature-based art activities, fun gross motor games and lots of water play—wading pools and sprinklers, water tables and water games! The children will also go on neighborhood walks including the new town rail trail, visit the animals at the Farmer's Exchange, visit the town playground and attend special events at the town library.

If you have a child registered for our upcoming 2024-2025 school year who is moving into a new classroom, our Summer Program will be a perfect introduction to the new classroom, and a great opportunity to begin creating relationships with the teachers and the other children enrolled in the program. Village Common Children's Center SUMMER PROGRAM POLICY

- Ages for the Infant/Toddler Programs are 8 weeks through 2 years 9 months. Ages for the Preschool/Pre-K/School-Age Program are 2 years 9 months through 6 years old.
- School Year Tuition must be paid up-to-date in order to enroll in the Summer Program.
- There is a non-refundable/non-applicable registration fee of \$55 per child, \$75 per family.
- A Tuition Fee Schedule is attached.
- If you are a current VCCC family who is also registered for the new school year, a Summer Program registration is required in order to retain the new school year registration. A minimum of **four weeks** during the summer, with each week equaling the number of days per week that was scheduled during the school year.
- Once the Summer Program begins, you are financially responsible for whatever weeks you have registered for. While you may be able to add weeks if needed (if space is available), you will not be able to delete weeks after the Program begins on July 8, 2024 because we will have already put our staffing schedule into place for the entire summer, which we will then have to honor financially.
- Like the school year program, tuition payments are due on Fridays for the following week of service.
- There is no reimbursement or "credit" if a child is out due to illness or family vacation.
